1:00pm to 4:00pm Workshop by Don Dillman, Washington State University Registration fee \$50.00 (USD)

Don Dillman will present a half-day workshop on new ways of conducting sample surveys. The emphasis will be on household surveys, using postal address-based sampling methods in a way that incorporates a "push" to respond over the web with a paper questionnaire follow-up. Much of Dillman's research during the past decade has been on developing and testing the use of such methods. The need for these methods stems in part from the rapid decline in adequacy of telephone survey methods combined with an inability to rely on email-only contact methods to seek a web response because of coverage and response problems. His discussion of data collection methods builds upon the 4th edition of his book, *Internet, Phone, Mail and Mixed-mode Surveys: The Tailored Design Method* (Dillman, Smyth, and Christian, 2014), which is a 70% revision of the 3rd edition

The recipient will also be recognized at the NRRIG business meeting. The paper submission should not exceed 35 double-spaced pages (including all tables, graphs, and references) in a standard font (12 point). Papers will be evaluated using the following criteria:

- 1. Advancement of knowledge.
- 2. Significance of the topic for the NRRG of the Rural Sociological Society.

- 3. Quality and implementation of the research, theory, and argument (as applicable).
- 4. Analysis and interpretation of the findings (if applicable).
- 5. Clarity and organization of the writing. (Criteria listed in order of importance/weight)
